### 7. New Business

7.1 Fall Low Water levels L. Bedel has received comments from ratepayers on

the low water levels of Pasqua Lake. T. Mullin commented that the current fall water levels are normal and suggested ratepayers who have boats on lifts should remove the boats by the end of Sept. to

avoid removal issues

7.2 SaskPower poles by #66 The poles in this area have a severe lean to them

and L. Bedel will inquire with local utility officials

to see if they plan to reset the poles next year.

### 7.3 Reduced assessment

S. Powell noted the Hamlet was impacted by a reduced assessment of \$900,000 as a result of the RM not including several properties within the Hamlet but yet received services provided by the Hamlet

Motion 22-23 by S. Powell "that the OHPL launch a review of the OHPL assessment due to the RM removing properties which were previously assessed in the OHPL but were actually in the RM. Since these properties use Pasqua Lake Road and all other services provided by the OHPL, the OHPL will review and prepare a document for presentation to the RM Council reflecting the back charges to be assessed to the RM and credited to the OHPL for servicing these properties"
