**Committee Motions:**

- 31-2023 Svedahl: THAT the minutes of the November 7, 2023, meeting be approved as presented. CARRIED
- 32-2023 Neu: THAT the Transition Committee approve the signing of the fire protection and rescue agreement with the Town of Fort Qu'Appelle, pending the amendment that the cost is based on population and not on number of houses, effective January 1, 2024. CARRIED
- 33-2023 Bedel: THAT the Transition Committee join North Valley Waste Management Association (NVWMA) as of January 1, 2024. CARRIED

- 36-2023 Bedel: THAT the Transition Committee accept the quote from Jackson Brothers Ind. Ltd. for the 2024 snow removal on Pasqua Lake's service roads. CARRIED
- 37-2023 Neu: THAT the Transition Committee approve the purchase of Munisoft's Option #1 software package for \$14,725 plus tax. CARRIED


The Transition Committee gave updates on the following:
