Bylaw No. 2024-09

A BYLAW TO PROVIDE FOR SITE FEES FOR CAMPGROUNDS AND RECREATION VEHICLE PARKS

The Council of the Rural Municipality of North Qu'Appelle No. 187, incorporated in the Province of Saskatchewan, enacts Bylaw No. 2024-09 as follows:

Title

1. This bylaw shall be referred to as the "Campground and Recreation Vehicle Fee Bylaw".

Purpose

- 2. The purpose of this Bylaw is to permit the operation of Campgrounds so as:
 - (a) to ensure compliance with land-use and building regulations;
 - (b) to provide for a service fee for the operation;
 - (c) to gather land-use information; and
 - (d) to facilitate planning decisions.

Definitions

- "Campground" shall mean an area used for a range of overnight camping experiences or accommodations, from tenting to serviced recreational vehicle sites.
- 4. "Occupied Site" shall mean a site within the definition of a campground that has been occupied for longer than 7 days.
- 5. "Campground Operator" shall mean every person who owns or operates any Seasonal Campground.
- 6. "Recreational Vehicles (RV)" truck camper, motor home, fifth wheels and travel trailers or other such approved accommodation intended for use in a campground.

General Regulations

- 7. No person shall operate a Campground within the boundaries of the Municipality without first obtaining a development permit to operate a Seasonal Campground as outlined within the RM of North Qu'Appelle No. 187 Zoning Bylaw.
- 8. The Campground Operator of a permitted Campground under this bylaw is hereby authorized and required to pay the Service Fee to the RM of North Qu'Appelle No. 187 as outlined in Schedule A that is annexed to this bylaw.
- 9. The Service Fees shall be due and paid no later than August 31st of the year in which the fees are imposed. Service Fees not remitted to the RM by August 31st of the current year shall be added to the tax card of the registered owner of the legal land description on which the Seasonal Campground is located and will form part of their taxes.
- 10. This bylaw shall be applicable to all existing Campgrounds, as well as those that may be developed in the future.

Offences and Penalties

11. Except where, or in addition to, a penalty is specifically provided for in this Bylaw, every person who contravenes any provision of this bylaw is guilty of an offence and liable on summary conviction to the penalties provided in the Offences and Penalties bylaws of the RM.



- 12. Pursuant to Section 370 of the Municipalities Act, 2006, the Administrator or Designated Officer may issue an injunction to any person that contravenes this bylaw, or any other Act or bylaw, to achieve bylaw compliance.
- 13. No person shall:
 - (a) obstruct or hinder any designated officer or any other person acting under the authority of this Bylaw; or
 - (b) fail to comply with any provision of this Bylaw.

Coming Into Force

14. This bylaw shall come into force on the day of its final passing.
