

A BYLAW TO EXTEND THE TIME REQUIRED FOR THE COMPLETION OF THE ASSESSMENT ROLL

The Council of the Rural Municipality of North Qu'Appelle No. 187 in the Province of Saskatchewan enacts as follows:

1. The time required pursuant to subsection 204(1) of *The Municipalities Act* for preparation of the assessment roll be and is extended to May 30, 2025.
