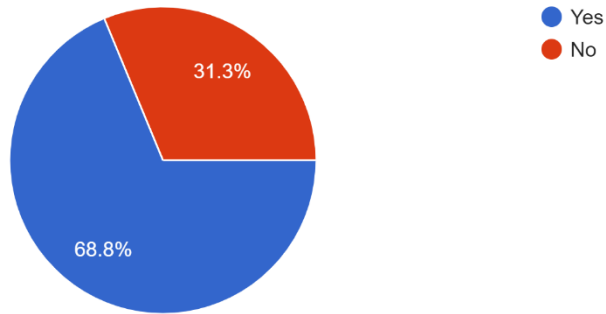


JASMIN ON ECHO SSA SURVEY RESULTS

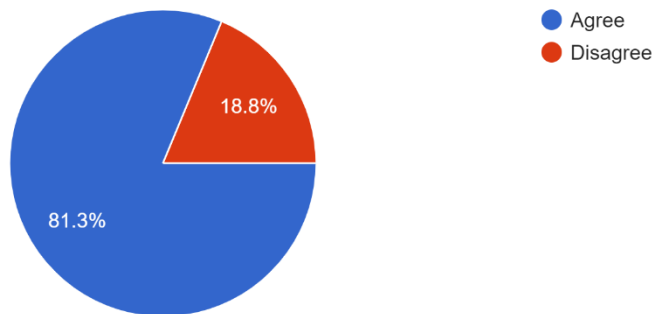
Does Jasmin on Echo have different needs than the rest of the RM?

Should Jasmin on Echo become an SSA they would no longer contribute to the general revenue of the RM. Do you agree or disagree with this?

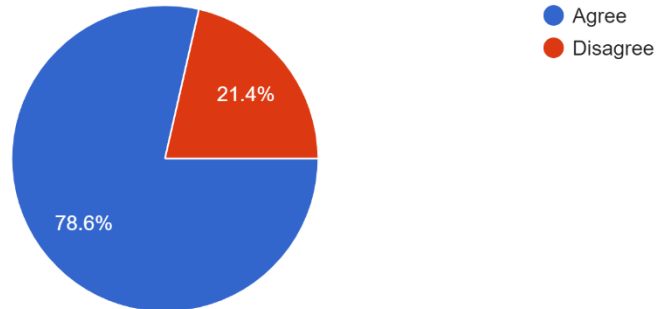

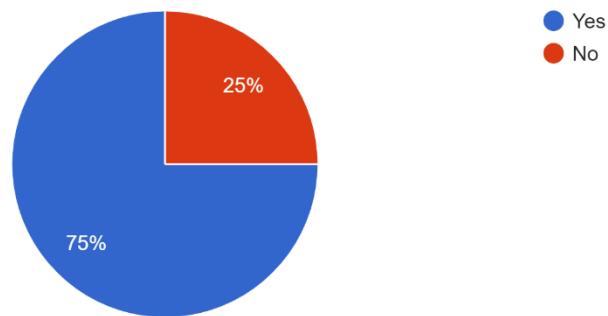

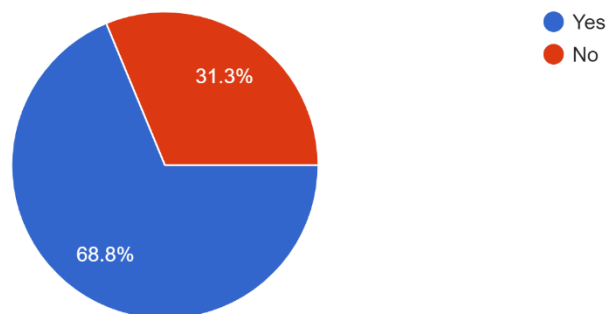
Are you aware that there will be no elected board to govern the SSA?

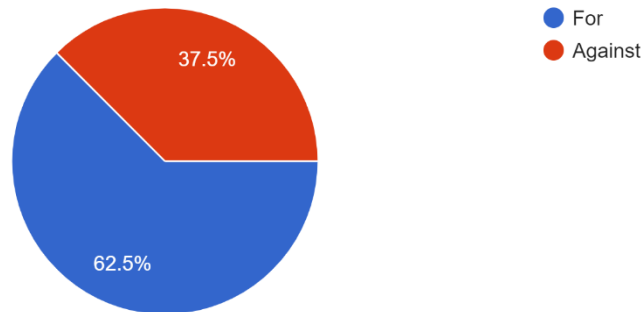

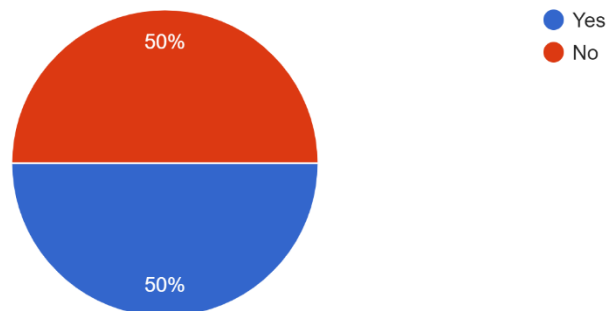
As a resident of the RM, are you for or against Jasmin on Echo becoming an SSA?

- I am concerned about the governance structure of an SSA. The same group of people who have failed to address the needs to the community for years would still be in charge. I would like to know if there are other options that would allow for better representation such as an organized hamlet .
- Some of these questions require a single yes or no for more than one topic covered in the question. The questions should only cover one topic to ensure the ratepayer has a choice to make a response for a single topic.

My response for the question regarding Jasmin having a different tax rate is YES My response for the second part of the statement that says the RM will not pay for services in Jasmin is NO. There may be occasion where the RM has the responsibility to pay for something that clearly falls under the jurisdiction of the RM. (eg municipal reserves) The questions also indicate that there is no input from the Jasmin rate payers in how tax revenue is allocated. If this is the case, then we might as well stick with status quo as we have no input today and as a result, nothing is done for the betterment of our community. These questions as worded contain a certain element of bias against Jasmin and our

quest to see our tax dollars spent on the betterment of our community. Some questions were a statement of fact, why is it in the survey? There is every opportunity to establish a governance model that would ensure that Jasmin and the RM work in a collaborative matter to effectively manage the SSA. As stated the RM make all the decisions whether Jasmin is an SSA or not. This question sounded like a threat....don't expect things to change. My final comment is who developed these questions? Was the survey vetted by Government Services. I look forward to your response.
